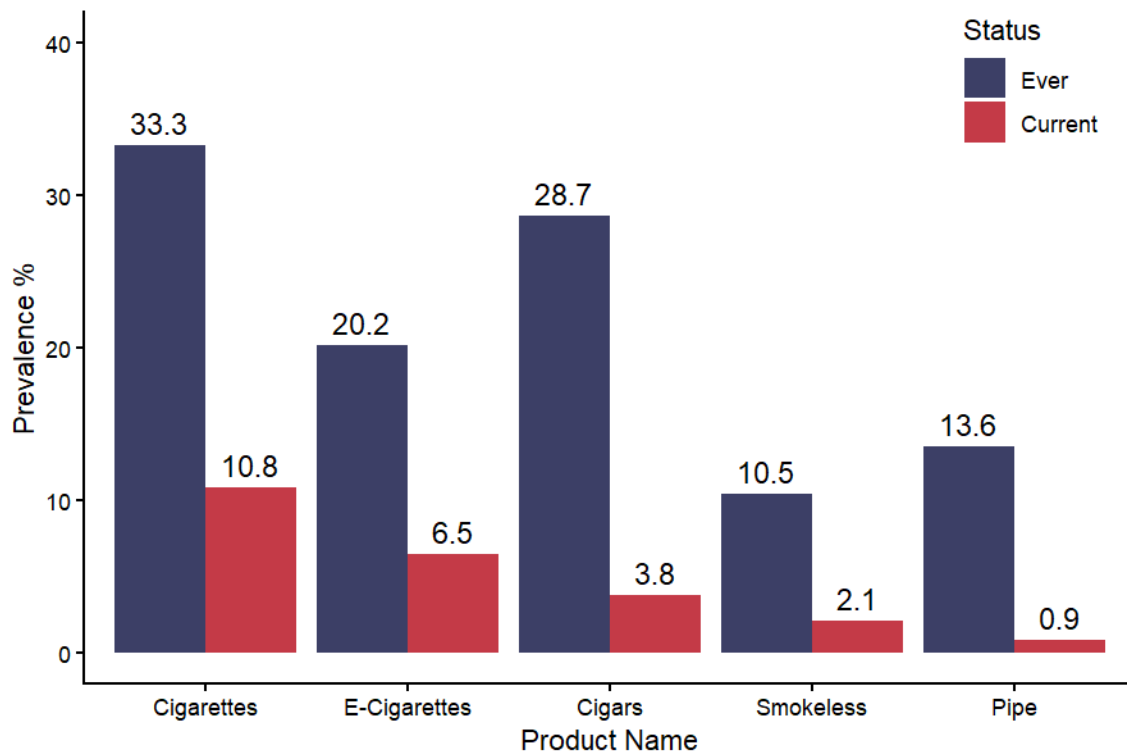




# Ever and Current Commercial Tobacco and Nicotine Product Use in the United States: National Health Interview Survey (2023)

CRST and CAStoR collaborated to present weighted prevalence estimates from analyses of the National Health Interview Survey (NHIS, 2023), an annual cross-sectional survey designed to be representative of the civilian noninstitutionalized US population. This brief presents results from adults in the 2023 NHIS, and includes estimated prevalence of ever and current use of commercial tobacco products, as well as current commercial tobacco product use by demographic characteristics.

### Technical Notes

For cigarettes, ever use is defined by answering yes to “Have you smoked at least 100 cigarettes in your ENTIRE LIFE?”. For all other products, ever use is defined by answering yes to “Have you ever [used product] EVEN ONE TIME?”. For all products, current use is defined by answering “every day” or “some days” to the question, “Do you NOW [use product] every day, some days, or not at all?”. Please note that participants who answer “some days” are included in current use even if they report 0 days of use in the past 30 days. Cigars includes “regular cigars, cigarillos, and little filtered cigars.” Smokeless includes “chewing tobacco, snuff, dip, snus, or dissolvable tobacco.” Pipe includes “regular pipes, water pipes, or hookahs.”

To account for the complex sampling design, variances were estimated using Taylor Series Linearization with the weight, stratum, and PSU variables applied.
